 4. To promote and develop health and nutrition for women and children.
 5. To promote integrated development of the area.

 7. To secure and raise funds, aids and other support from national and international agencies, governmental agencies to carry out the activities of the Association.

Revised RULES AND REGULATIONS OF THE ASSOCIATION

People's Action for National Integration

1. **Name** - The name of the Association will be, 'People 'S Action for National Integration'
2. **Registered office;** The registered office of the Association shall be situated at Sai Sadan, Plot No. 530, Near JB polytechnic, Civil Lines Faizabad, Uttar Pradesh, 224001
3. **Working Area-** All India.
4. **Membership of the Association :** The association shall have the following categories of memberships:

1. All Persons who have formed the Association and whose names and signatures are given under Section 5 of the memorandum shall be founder members of the Association.
2. **Ordinary Members:** Any individual citizen of India shall be eligible for the membership subject to acceptance of the Executive Committee.

Membership Fee:

1. Founder member Rs 10/- per annum
2. Ordinary member Rs 100/- per annum
3. Personnel of PANI Sansthan would be eligible for the ordinary membership of general body (subject to the approval of governing board) and thereby contest in the election process of governing board.

5. Cessations of membership: Membership shall cease:

- a. on death of member; or
- b. If member becomes of unsound mind; or
- c. If member becomes insolvent or is convicted of a criminal offence involving moral turpitude; or
- d. When member's resignation is accepted by chairman/ executive committee;
- e. Non payment of membership fees consecutively for three years.

6. Composition of association:

- a. General Body
- b. Executive Committee

General Body:

- a. The General Body will consist of all kinds' members of the association.
- b. **Meeting of the General Body:** The General Body of the Association shall meet at least once a year at such place as the Executive Committee may decide. Any special meeting of General Body may be called whenever necessary.
- c. Every member shall be entitled to receive at least 15 days notice of any General Body meeting of the Association; but emergent meeting can be called on short notice.
- d. **Quorum:** One quarter of total membership of the association shall form the quorum of the General Body of the Association.

8. Executive Committee:

a. The Elective Committee shall comprises of minimum seven members including office bearers :-

- i) Chairman ii) Vice-Chairman
iii) Secretary iv) Four members

b. Meeting :

i. The Executive Committee shall meet at least twice a year at such time and place as the Chairman may decide.

c. Every member shall be entitled to receive 7 days notice of any meeting of the Executive Committee's.

d. Quorum :

At any meeting one third or a minimum of three members of the executive committee shall form the quorum of the meeting.

e. Vacancies:

Any vacancy arising among office bearers or member of the Executive committee during their tenure of office shall be filled in by the Executive Committee from amongst the members of the Association.

f. All powers of administration, management, supervision and initiation of programs shall vest in the Executive committee. Whenever necessary, the executive Committee may delegate its powers to office bearers or sub-committees to initiate and execute programs. The executive committee is empowered to make its own bye-laws.

g. Tenure of office:

The Present Executive Committee shall be in office for a term of three years in accordance with the provision of these rules at the General Body meeting, the term of the Executive Committee would however automatically extend till the next election takes place. All members of the Executive committee would be eligible for reelection.

10. Duties of office bearers:

a) Chairman:

The chairman of the Association shall be the chairman of all the meetings of the Association and would be overall in-charge of the Association.

b) Vice-chairman:

In the absence of the chairman, the vice-chairman shall preside over the meetings and perform such other duties as may be delegated by the chairman.

Secretary: The duties of the Secretary shall be:

To implement, administer and carryout the approved programs and activities of the Association, He will also be empowered to initiate and undertake programmers whenever necessary.

ii. To keep records of the proceedings of all the meetings of the Association and to maintain list of members of the association and necessary information pertaining to their activities.

iii. To carry on correspondence on behalf of the Association and to have custody of the records and files of the Association.

iv. To maintain regular accounts, prepare periodical reports and statements of account of the Association to the Executive Committee and General Body.

v. To borrow on behalf of the Association, after due authorization of the Executive Committee, funds or loans from financial and/or lending institutions.

vi. Whenever necessary to undertake tour in the interest of the Association,

vii. To receive and disburse amounts and incurred expenditure as per approved budget.

viii. To be in-charge and take care of all assets, equipments, machinery, buildings etc,

ix. The Secretary may delegate all or any of his powers and functions to any member of the Association,

11. **Amendment of Constitution:**

The Constitution can be amended or altered at any General Body meeting of the Association by a two-third vote of members present at such meeting.

12. **Funds:** The association, Shall raise its funds from the following sources:

- i. Membership fee
- ii. Grants from central & state government
- iii. Grants, contribution, donation from Members, Non-members, Local bodies, national and international funding agencies etc.
- iv. The Bankers of the association shall be decided by the Executive Committee, all Funds will be deposited in the name of the Association's account with the said bank. The signatory will be decided by the Executive Committee,
- v. Income and receipts from other sources including borrowing and advance from financial and lending institutions such as banks, financial corporation, state Agencies, etc,

13. **Audit:**

The accounts of the Association shall be audited by a qualified auditor or auditors appointed by the General Body

14. **Legal Action:**

All Legal actions will by sued in the name of the secretary of the Association;

15. **Record:**

All records such as membership and minute's book, stock book, cash book/ledger etc. will be in the custody of the Secretary

16. **Dissolution of the Association:**

- i. The Association, may be dissolved by the decision of at-Least three-fifth of the total members of the Association, arrived at in a meeting or by obtaining the approval there of the required number by circulation to all members,

- ii. On dissolution of the Association, if any property remains; after satisfying all the debts and liabilities of the Association, it shall not he divided among the members of General Body on the Executive Committee; But shall be transferred to some other Society having similar objectives according to the provision of the Section 14 of the Registration of Societies Act XXI of 1860.
